

Terms and Conditions

1. Definitions

- 1.1 The term 'Retailers' refers to all participating Specialty Stores and Majors at Q Super Centre only.
- 1.2 A retail purchase made at a Participating Retailers during the Promotional Period. Each retailer purchase must be evidenced by the original transaction receipt. The following retail purchases are EXCLUDED for the purposes of the Promotion:
- a) Transaction receipts for travel purchases over \$5,000
 - b) Cash advances/withdrawals, account charges, government fees, interest charges, real estate purchases, bill payments, medical service expenses, purchases of cash substitutes (e.g. retailer gift vouchers and Q Super Centre Gift Vouchers), or ATM/Bank Transactions.
 - c) Lay-by payments, except where the amount paid completes the transaction;
 - d) EFTPOS transactions, except where there is a retail purchase component. This excludes additional money debited for personal use at the time of the retail purchase;
 - e) Business purchases over \$5,000;
 - f) Transactions from any banking or financial institution, insurance company or government entity;
 - g) Lottery transactions.
- 1.3 The term 'Promotion Period' means the period commencing 10am Monday 12th July 2010 until 5pm Sunday 29th August 2010. All customer receipts must be placed in the entry barrel or redeemed at Centre Management by closing time and date.

- 1.5 'Prize' refers to the prizes described in clause 3 to be awarded by the promoter in conjunction with the promotion.
- 1.6 'Promotion' refers to 'School Rewards'
- 1.7 'Nominated School' refers to Benowa Primary School, St Vincent's Primary School, Merrimac State School, Robina State School and Broadbeach State School.
- 1.8 'Points' are calculated according to the total dollar value of receipts from Eligible Retail Purchases from Specialties and Majors in Q Super Centre. For example: if the receipt value equals \$50 then the total points redeemed for the Customers Nominated School is 50 points. In the case that a receipt value \$50.49 or less the total points redeemed for the Customers Nominated School will be rounded down to 50 points or if the receipt value is for \$50.50 or more the total points redeemed for the Customers Nominated School will be rounded up to 51 points.

2. Details of the Promotion

- 2.1 The Promotion is open to all Q Super Centre Customers
- 2.2 To redeem Points for a Customers Nominated School, the customer must place the receipts to the value of any dollar amount from any specialty store or major within Q Super Centre in the school specific entry boxes or have your receipt recorded and stamped at Centre Management.
- 2.3 Receipts can only be presented once to redeem points for a Customers Nominated School.
- 2.4 Customer's receipts evidencing retail purchases will not be kept by the Promoter. Receipts can also be presented to Centre Management, recorded and stamped by a Q Super Centre representative. Stamped and recorded receipts cannot be re-presented to redeem points for a Customers Nominated School.
- 2.5 The following types of documentation will not be accepted as proof of an Eligible Retail Purchase:
- a) Transaction statements as issued by a bank or financial institution;
 - b) Receipts that do not adequately or legibly identify all of the following: the name of a Retailer and/or ABN, date and purchase price
 - c) Receipts from retailers not within Q Super Centre
- 2.6 Each week the entry boxes will be emptied and the receipts to determine points will be calculated
- 2.7 Tallies will be available online and in-centre each week to show the schools positions.
- 2.8 For every dollar spent during the weeks commencing 19th July 2010 and 9th August 2010 in the Promotion Period the customer will receive double points i.e. two (2) points per dollar spent instead of one (1) point per dollar.

3. The Prize

3.1 The school with the highest average spend per student wins the following cash prizes:

1st: \$2,000.00 2nd: \$1,000.00 3rd: \$500.00

4. Prohibited Behaviour

4.1 Prohibited behaviour includes, but is not limited;

a) Soliciting for receipts within Q Super Centre or Carpark by standing outside store entrances asking for receipts and searching

through trolleys or bins.

b) Asking retailers for unclaimed receipts or duplicate receipts.

c) Presenting receipts that have previously been entered

d) Presenting forged receipts or receipts that have been materially altered

e) Presenting receipts for goods already returned or failing to advise the Promoter to delete preaccrued points for goods subsequently returned.

5. Promoter's Rights

5.1 By accepting the prizes, the winners agree to participate in any publicity arrangements made by or on the behalf of the Promoter in relation to this Promotion. The Promoter reserves the right to publicise the finalists name, suburb and photograph through newsletters, print and electronic media and broadcasts.

5.2 The Promoter will not be responsible for delayed, lost or misdirected mail or any other communication.

5.3 To the extent permissible by law, Customers release the Promoter from any causes of action, loss, liability, damage, expense (including any claim for legal expenses), cost or charge sustained or in any way incurred, as a result of participation in the Promotion.

5.4 The Promoter's decision in relation to all aspects of the Promotion are final and binding and no correspondence will be entered into.

5.5 The Promoter may in absolute discretion change, amend or vary these Terms and Conditions.
